

## UOBM - MYDIN RM ONE RINGGIT DEAL 2018

### TERMS & CONDITIONS

United Overseas Bank (Malaysia) Bhd (271809-K) (“UOBM”) and MYDIN collectively referred to as the (“Organisers”) are organising “**UOB - MYDIN RM One Ringgit Deal 2018**” (“Promotion”) from 8 December 2018 until 15 February 2019 (both dates inclusive) or such other dates as may be determined by UOBM from time to time (“Promotion Period”).

#### ELIGIBILITY

1. This Promotion is open to all eligible principal and supplementary UOBM Credit and/or Debit Cardmembers (“Cardmembers”) whose accounts with UOBM are current, valid, subsisting and in good credit standing as may be determined by UOBM at its sole and absolute discretion.
2. This promotion is only applicable to UOBM Credit and/or Debit Cards issued in Malaysia (“Card”).
3. The following shall not be eligible to participate in this Promotion:
  - a. All UOBM Corporate, Purchasing and Private Label Cardmembers;
  - b. Cardmembers whose account(s) are terminated, suspended or cancelled within the Promotion Period; and
  - c. Cardmembers whose account(s) held with UOBM are delinquent or unsatisfactorily conducted as determined by UOBM at its sole and absolute discretion.

#### CAMPAIGN MECHANICS

4. The Cardmembers are required to spend a minimum of RM100 in a single receipt with their UOB credit or debit card only at MYDIN Hypermarket Subang Jaya (“Spend”), to redeem any two of the items which are Nescafe Classic Refill 100gm, Maggi Curry Instant Noodles 5x79gm or Milo Activ-Go Refill 400gm at RM 1 (“Redemption”).
5. Redemption will be awarded to all Cardmembers subject to fulfilling the below criteria:-
  - a. Redemption must be made at MYDIN Hypermarket Subang Jaya Redemption Counter (“Counter”) where the spending is made on the same day only.
  - b. Eligible Customers are required to present the followings upon Redemption at the Counter:-
    - i. Where Spend is applicable
    - ii. the UOBM credit or debit card and the original receipt
  - c. Redemption cannot be exchanged for cash or for any other products.
6. The below Spend is not eligible under this Promotion:
  - a. Split and/or void transactions;
  - b. Reversals or refunds; and
  - c. Such other transactions as UOBM may determine from time to time.

If there is any inconsistency between these terms and conditions and the terms and conditions in the Cardmember Agreement in connection with this Promotion, these terms and conditions shall prevail.
9. The decision of The Organisers in relation this Promotion shall be final, conclusive and binding on the Cardmembers. The Organisers shall not be obliged to give any reasons or entertain any correspondence with any person(s) on any matter concerning this Promotion. No appeals and/or correspondence from any Cardmembers or any third party will be entertained.
10. The Organisers shall not be liable for any misinterpretation or misrepresentation of facts by any unauthorised third party in respect of the Promotion and published in any mass media, marketing or advertising materials.
11. The Organisers shall not be responsible nor shall accept any liabilities of any nature and however arising or suffered by the Cardmembers and/or any third parties resulting directly or indirectly from the Promotion unless it arises from The Organisers negligence or wilful misconduct specifically related to the Promotion.
12. UOBM is not affiliated with the Mydin and makes no representation or warranty with respect to the quality of the items and/or services supplied by the Mydin.
13. To the fullest extent permitted by law, The Organisers expressly excludes and disclaims any representations, warranties or endorsements, express or implied, written or oral, without limitation to those published in any mass media, marketing or advertising materials, including but not limited to, any warranty of quality, merchantability or fitness for a particular purpose in respect of this Promotion.
14. In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and other materials relating to or in connection with this Promotion, these terms and conditions shall prevail.
15. The Organisers reserves the right to add, delete, suspend or vary the Promotion’s terms and conditions, from time to time, wholly or in part, at its absolute discretion, by providing twenty one (21) calendar days prior notice to the Cardmembers through posting on UOBM’s website, displaying a notice at any of UOBM’s branches and/or a statement insert in the Statement of Account or any other manner as determined by UOBM from time to time.

The Organisers reserves the right at its absolute discretion to cancel, withdraw, terminate, extend or suspend this Promotion prior to the expiry of the Promotion Period, wholly or in part, at any time with prior notice. For the avoidance of doubt, any cancellation, withdrawal, termination, extension or suspension by The Organisers of this Promotion shall not entitle the Cardmembers to any claim or compensation against The Organisers for any and all losses or damages suffered or incurred by the Cardmembers whether as a direct or indirect result of such cancellation, withdrawal, termination, extension or suspension.
17. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and the Cardmembers agree to submit to the non-exclusive jurisdiction of the courts of Malaysia.
